Global Highlights

🌐 **US: CPI, core PCE inflation remained steady; unemployment rose**

The US Consumer Price Index (CPI) increased by 0.3% mom in November, higher than October's 0.2%. On a yoy basis, CPI accelerated to 2.7%, but this was in line with expectations (October: 2.6%). Core CPI rose by 0.3% in November, also unchanged from October, and increased by 3.3% yoy, consistent with October's 3.3%. Separately, the Fed's preferred inflation gauge, the core PCE inflation increased by 0.3% mom in October, unchanged from September, resulting in a yoy increase of 2.8% (September: 2.7%) (Note: November's figures are not out yet at the time of writing). Separately, the unemployment rate increased to 4.2% in November from 4.1% in October.

🌐 **EU: Eurozone weakened; Germany, France face economic challenges**

Eurozone economic data showed continued weakness, with the PMI dropping to a 10-month low of 48.1%, indicating contraction in services and manufacturing. Annual inflation rose from 2.0% in October to 2.3% in November. Separately, Germany's coalition government collapsed after Chancellor Scholz sacked the finance minister, triggering new elections in February. France faced rising borrowing costs due to debt concerns and budget challenges.

🌐 **China: PMIs improved amid stimulus measures, but CPI and PPI remained discouraging**

The China's manufacturing PMI improved to 50.3% in November from 50.2% in October. Non-manufacturing PMI came in at 50.0% in November, down from 50.2% in October. Separately, the Caixin/S&P Global manufacturing PMI increased to 51.5% in November from 50.3% in October. To note, the official and Caixin surveys have different samples, with the Caixin PMI focusing on export-oriented enterprises and SMEs in the country's coastal region.

China's CPI rose just 0.2% yoy in November, below the expected 0.5%, and down from 0.3% in October. Core CPI edged up from 0.2% to 0.3% in November, indicating weak inflationary pressure. Meanwhile, PPI fell from -2.9% yoy to -2.5% in November, marking the 26th consecutive month of negative growth, highlighting persistent production sector pricing pressures.

Malaysia Highlights

🌐 **Malaysia: Price pressure remained under control in October**

In October, Malaysia's headline inflation expanded to 1.9% yoy (September: 1.8%) driven by higher food costs. Core inflation steadied at 1.8% yoy in October. Headline inflation moderated thus far this year (10M24: 1.9% vs. 10M23: 2.7%) as the high base effect wears off, together with some normalisation in commodity prices.

🌐 **Malaysia: Exports and imports rebounded in October**

Malaysia's export exports rebounded in October, to 1.6% growth yoy, supported by expansion in E&E shipment. On the other hand, import grew 2.6% yoy in October. On a mom basis, both exports and imports rebounded in October, up 3.7% and 4.8% respectively. Malaysia's exports and imports improved yoy for the period of 10M24, up 4.8% and 14.6% respectively. Finally, Malaysia recorded a lower trade surplus of RM12bn in October (vs. RM12.8bn in September).

Market Performance

- 🌐 **Shanghai Shenzhen CSI300 Index** gained 0.7% in November, showing a slight recovery after last month's pullback due to stimulus concerns. However, the Hong Kong Hang Seng Index declined by 4.4%, as internet, auto, and energy stocks suffered high single-digit declines, signaling weakening consumer sentiment.
- 🌐 **Dow Jones Index** rose by 7.5%, S&P 500 increased by 6.2% while Nasdaq gained 5.7% in November following Donald Trump's presidential win, with expectations of growth, tax cuts, and deregulation. The Republican Party also gained control of Congress, which could make it easier for Trump to implement his campaign promises. Top-performing sectors included consumer discretionary and financials, while healthcare and materials lagged.
- 🌐 **Euro Stoxx 50 Index** dropped by 0.5% in November amid concerns about growth and uncertainty around the US presidential election outcome. The information technology and communication services sectors were among the top gainers, while materials and consumer staples suffered some of the steepest declines. Exporters were in focus amid concerns over potential tariffs from the US, as well as ongoing lackluster demand from China. However, the stronger dollar should prove beneficial.
- 🌐 **Nikkei 225 Index** was down by 2.2%, indicating that the market's correction concentrated on large-cap stocks, particularly exporters. Investor sentiment declined due to concerns over potential global tariffs and trade restrictions on China, hurting the performance of Japanese exporters, including autos, technology, and basic materials.
- 🌐 **FBMKLCI Index** fell by 0.5% mom in November, closing at 1,594.29. Conversely, the Small Cap Index gained 2.0%, and the Mid 70 Index increased by 1.5%. Sector-wise, the top performers were Healthcare, Plantation, and Utilities, with gains of 5.3%, 3.8% and 3.6% mom, respectively. Laggards were Telco, Energy and Industrials, which declined by 3.1%, 2.8% and 2.2%, respectively. In terms of fund flow, foreign investors continued to be net sellers in November, recording net sell flows of RM3.1bn. This turned cumulative foreign flows to a net outflow position of RM1.3bn for the first eleven months of 2024.

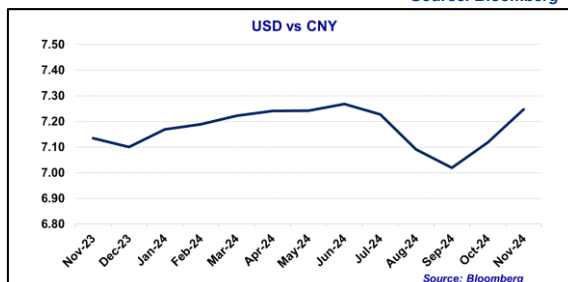
Currency

- 🌐 **USDCNY**: The CNY depreciated by 1.8% against the USD in November, driven by a stronger dollar. The Dollar Index rose 1.8% to 105.8 following Trump's win, which raised concerns about inflation, higher tariffs, and increased fiscal spending.
- 🌐 **USDJPY**: The JPY appreciated by 1.5% in November. Despite further depreciation following Trump's win, it strengthened against the US dollar towards the month's end, driven by expectations of additional rate hikes by the Bank of Japan (BOJ), possibly in December.
- 🌐 **USDMYR**: The MYR declined by 1.6% in November due to a stronger dollar.

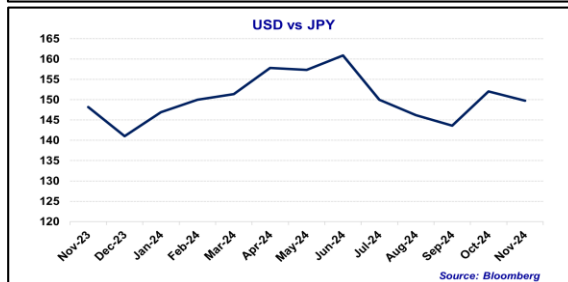

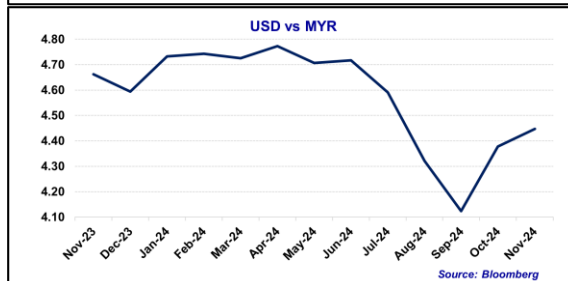

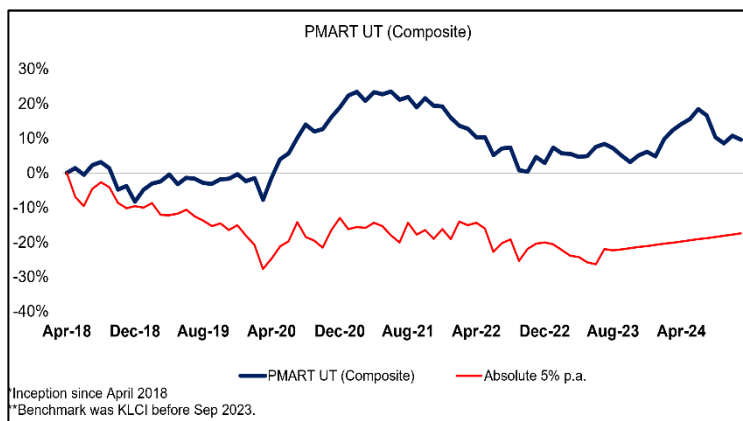

Market Outlook

- With Trump's 2024 trade policies are expected to mirror his "America First" approach, aiming to reduce the US trade deficit, protect American jobs, and challenge perceived unfair trade practices, particularly with China. Proposed measures include blanket import duties and a 60% tariff on Chinese goods, likely provoking retaliatory tariffs and raising import costs. This could lead to higher prices for US consumers and reduced demand, slowing global trade. In contrast, Malaysia has benefitted from the US-China trade war, with re-exports growing and foreign direct investment (FDI) surging, especially in sectors like electronics, semiconductors, and green technology. Our outlook on global equities remains cautiously optimistic. We favour US equities due to strong corporate earnings and positive economic data. Trump's proposed corporate tax cut to 15% could further enhance earnings potential for US companies, providing additional support to the market. As we approach the tail end of 2024, we anticipate continued market volatility. In this environment, we are maintaining a cautious approach to sector and theme selection, particularly in areas where valuations appear stretched relative to fundamentals.
- Locally, we remain focused on the technology and industrial sectors, as Malaysia stands to benefit from the US's planned tariff increases on Chinese imports such as semiconductors, batteries, solar cells and critical minerals. This is expected to attract multinational companies seeking alternative investment destinations, while the strong USD should further boost sector earnings.

- **Worst Performer** – Manulife Investment Shariah Asia-Pacific ex Japan Fund – The fund's underperformance was dragged by its high exposure in Hong Kong/China, India and Korea.
- **Allocation** – Following Trump's win, we reduced our Asia (AHAM Select APAC (ex-Japan) Dividend MYR Fund, KAF Jade Fund, Manulife Investment Shariah Asia-Pacific ex Japan Fund and Principal Greater China Equity MYR Fund) and Malaysia equity (Eastspring Investments Growth Fund, Kenanga Growth Series 2 MYR Fund and Kenanga Shariah Growth Opportunities Fund) exposure in November and will shift towards bonds in December as we adopted a more cautious stance. 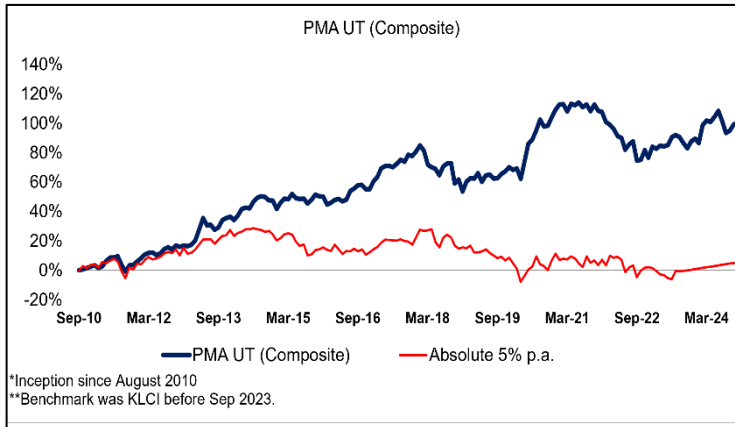

- **Top Performer** – Kenanga Shariah Growth Opportunities Fund – The fund's strong performance was supported by its conviction picks in the Industrial, Technology and Construction sectors.
- **Worst Performer** – Manulife Investment Shariah Asia-Pacific ex Japan Fund – The fund's underperformance was dragged by its high exposure in Hong Kong/China, India and Korea.
- **Allocation** – Following Trump's win, we reduced our Asia (Manulife Investment Shariah Asia-Pacific ex Japan Fund and Principal Islamic Asia Pacific Dynamic Equity MYR Fund) and Malaysia (AHAM Aiman Growth Fund, Kenanga Shariah Growth Opportunities Fund, Manulife Investment Al-Fauzan Fund and PMB Shariah Equity Fund) equity exposure in November and will shift towards bonds in December as we adopted a more cautious stance. Despite having a constructive view on the US market, we are unable to initiate a US position due to the limited universe of approved Shariah funds by the provident fund. We will continue to monitor the performance of the funds and rebalance the portfolio, when necessary, in line with the market condition.

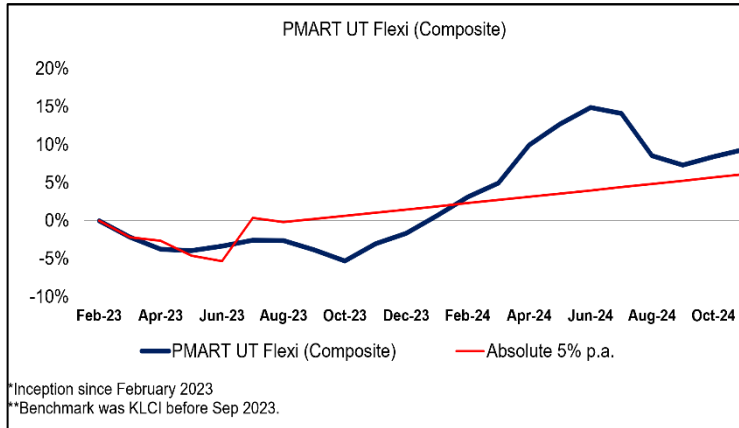

- **Top Performer** – Manulife Investment-HW Shariah Flexi Fund – The fund's strong performance was supported by its conviction picks in the Industrial, Healthcare and Construction sectors.
- **Worst Performer** – Principal Islamic Asia Pacific Dynamic Equity MYR Fund – The fund's underperformance was dragged by its high exposure in Hong Kong/China, India and Korea.
- **Allocation** – We made no changes to the portfolio for the month of November. We will continue to monitor the performance of the funds and rebalance the portfolio, when necessary, in line with the market condition.

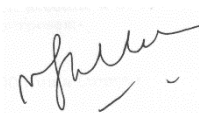
