Global Highlights

🌐 **US: CPI turned stickier than expected; unemployment declined**

The US Consumer Price Index (CPI) increased by 0.5% mom in January, higher than December's 0.4%. On a yoy basis, CPI ticked up at 3.0% (December: 2.9%). Core CPI rose by 0.4% in January, significantly higher than December's 0.2%, and increased by 3.3% yoy, slightly higher than December's 3.2%. Separately, the Fed's preferred inflation gauge, core PCE inflation, increased by 0.2% mom in December, up from November's 0.1%, resulting in a yoy increase of 2.8% (November: 2.8%) (Note: January's figures were not available at the time of writing). Additionally, the unemployment rate decreased to 4.0% in January, down from 4.1% in December, marking the third consecutive month of decline.

🌐 **EU: Eurozone PMI expanded; inflation rose; ECB and BOE eased policies**

The HCOB flash Purchasing Managers' Index (PMI) indicated that business activity in the eurozone returned to growth. The composite PMI increased to 50.2% in January, up from 49.6% in December, as the decline in manufacturing activity slowed. Annual inflation rose from 2.4% in December to 2.5% in January, driven by higher energy prices. The core rate, which excludes energy, food, alcohol, and tobacco prices, remained steady at 2.7%, for ninth consecutive months. Meanwhile, the jobless rate remained at 6.3% in December. The European Central Bank (ECB) reduced its rate from 3.00% to 2.75% in January, while the Bank of England (BOE) cut its benchmark Bank Rate by 25bps to 4.5% in its February decision.

🌐 **China: PMI weakened, CPI rose, PPI negative**

China's manufacturing PMI weakened to 49.1% in January, down from 50.1% in December. The non-manufacturing PMI came in at 50.2% in January, down from 52.2% in December. Separately, the Caixin/S&P Global manufacturing PMI edged down to 50.1% in January from December's 50.5%. To note, the official and Caixin surveys have different samples, with the Caixin PMI focusing on export-oriented enterprises and SMEs in the country's coastal region.

China's CPI saw a modest increase in January, rising 0.5% yoy, higher than December's 0.1%. Core CPI edged up from 0.4% to 0.6% in January. Meanwhile, PPI remained unchanged at -2.3% in January, marking the 28th consecutive month of negative growth, highlighting persistent pricing pressures in the production sector.

Malaysia Highlights

🌐 **Malaysia: CPI and core CPI eased in 2024**

Malaysia's full-year CPI for 2024 is 1.8%, with core CPI also at 1.8%, compared to 2.5% and 3.0% in 2023, respectively. Food and Non-Alcoholic Beverages eased from 4.8% to 2.0%. Housing, Water, Electricity, Gas, and Other Fuels increased from 1.7% to 3.0% owing to a partial removal of electricity tariff rebate. Transport eased from 1.1% to 0.9% amid lower average price of RON97 vs. in 2023.

🌐 **Malaysia: Trade increased in 2024; exports and imports rose**

Malaysia's total trade grew by 9.2% yoy in 2024, driven by a 5.7% increase in exports and a 13.2% rise in imports. In contrast, total trade in 2023 shrank by 7.3%, with exports declining by 8.0% and imports falling by 6.4%. However, the overall trade balance in 2024 stood at RM137 billion, compared to RM215 billion in 2023. The yoy improvement in trade data could reflect front-loading of shipments prior to the potential implementation of US tariff policy. We believe this trend could continue in the next few months.

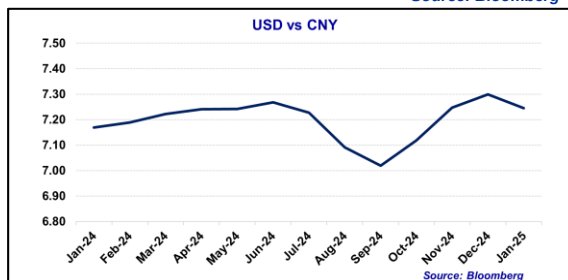
Market Performance

- 🌐 **Shanghai Shenzhen CSI300 Index** lost 3.0% in January, given ongoing uncertainty about Trump's proposed tariffs on US imports of Chinese goods. However, without the impact of the Chinese New Year holiday, the index might have actually seen gains, similar to the Hang Seng Index, which rose 0.8% in January. News that China's DeepSeek created a generative AI model comparable to market leaders, but at a lower cost, boosted market prospects for China/HK equities.
- 🌐 **Dow Jones Index** rose by 4.7%, S&P 500 climbed 2.7% while Nasdaq gained 1.6% in January as the US economy continues to show signs of strength, with 256,000 jobs added in December and healthy GDP growth of 2.3% annualised in the fourth quarter. However, the US market's heavy tech concentration contributed to volatility towards the end of the month, as DeepSeek's ability to produce efficient, low-cost AI models negatively impacted Nvidia, the largest constituent of the S&P 500 Index.
- 🌐 **Euro Stoxx 50 Index** gained 8.0% in January aided by low tech exposure and upward revisions in 2025 earnings expectations. The eurozone also benefited from a rotation out of US tech stocks in January (mainly to Banks and Consumer Discretionary), while worries over trade tariffs eased. Separately, Eurostat data revealed that the eurozone economy stagnated in Q4 2024, resulting in an estimated annual GDP growth of 0.7% for the region in 2024
- 🌐 **Nikkei 225 Index** lost 0.8%, with the Japanese equity market showing initial weakness before recovering modestly in the second half of January. Volatility increased due to fluctuations in large-cap technology stocks and exporters. Market sentiment was shaped by US inflation concerns and tariff uncertainties, but rebounded after positive tariff reports and SoftBank's AI investment announcement.
- 🌐 **FBMKLCI Index** declined by 5.2%, closing at 1,556.92. Similarly, the Small Cap Index fell by over 5.1%, while the Mid 70 Index saw a decrease of 6.7%. Sector-wise in January, the worst-performing sectors were Construction, Technology and Utilities, which saw losses of 13.5%, 10.5%, and 9.9%, respectively. On the other hand, REITs and Energy were the only sectors to post small gains, up 0.4% and 0.1%, respectively. Foreign investors continued to be net sellers for the fourth consecutive month in January, recording net sell flows of RM3.1bn, with outflows totaling RM10.9bn over the past four months.

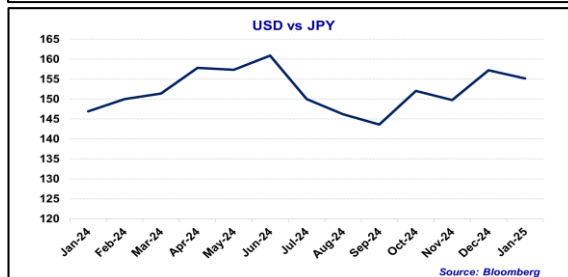

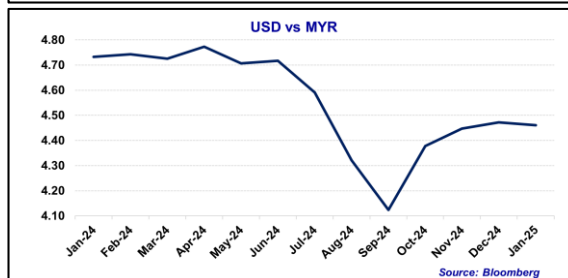

Currency

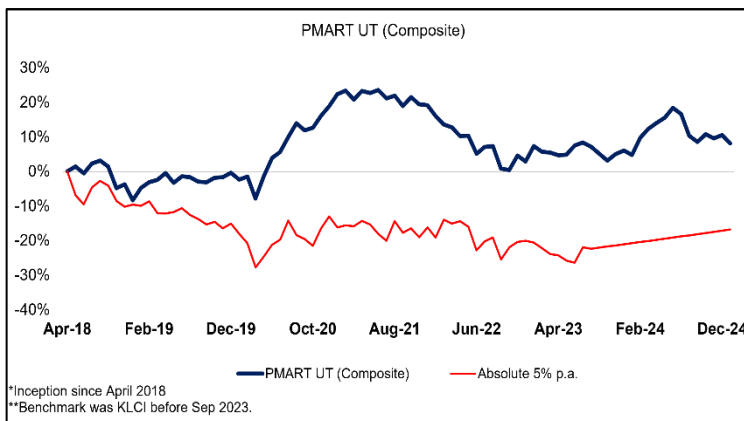
- 🌐 **USDCNY**: The CNY strengthened by 0.7% against the USD in January, driven by hopes of milder tariffs imposed by Trump. Meanwhile, the Dollar Index declined 0.1% to 108.4.
- 🌐 **USDJPY**: The JPY appreciated by 1.3% against the USD in late January after the Bank of Japan (BoJ) raised its policy rate, a widely expected move. The JPY was further supported by a narrowing interest rate gap and relatively low volatility.
- 🌐 **USDMYR**: The MYR remained range-bound throughout the month, influenced by trade/tariff developments and broader risk sentiment, with a slight appreciation of 0.3% in January, closing the month higher.

Market Outlook

- DeepSeek has become a key market concern in January, with its cost-efficient use of lower-tier chips challenging US tech dominance. Our analysis suggests that if this trend persists, it could reshape the global semiconductor industry. We believe it is crucial to monitor responses from major tech firms, which have committed billions to AI infrastructure, as demand for high-end AI chips may decline. Separately, after announcing a 25% tariff on imports from Canada and Mexico, President Donald Trump agreed to delay them for one month. However, the 10% tariff on China remains set to take effect from 4 February onwards. The tariffs are aimed at addressing the fentanyl crisis, protecting US industries, and negotiating better deals. We believe US Treasury yields are likely to stay elevated and the dollar is likely to strengthen amid tariffs. We favour the US over Asia-Pacific for now, as US equities are likely to benefit from tariffs and a stronger dollar. As global markets grapple with heightened uncertainty, we emphasize the importance of diversification and a focus on quality amid volatility.
- The Malaysian market, too, saw weak performance in January, primarily due to profit-taking and foreign selling, particularly in AI/DC-related stocks, after news of Deepseek's Large Language Model (LLM) performance dampened sentiment on capex investment. However, we believe that Moody's reaffirmation of Malaysia's sovereign credit rating at 'A3' – an upper-medium grade with low credit risk – highlights the country's continued appeal as an investment destination. On a separate note, Malaysia market has never been this attractive in quite a while, with foreign shareholding hitting a record low of 19.4% in January. The KLCI now trades at 13.6x P/E, 1 standard deviation below its 10-year mean.

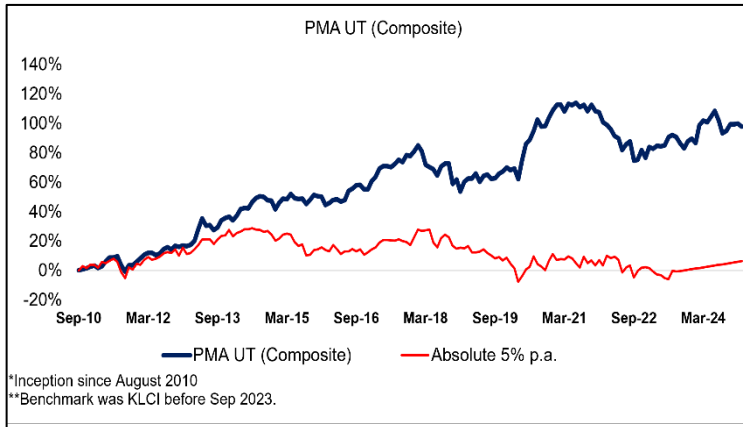

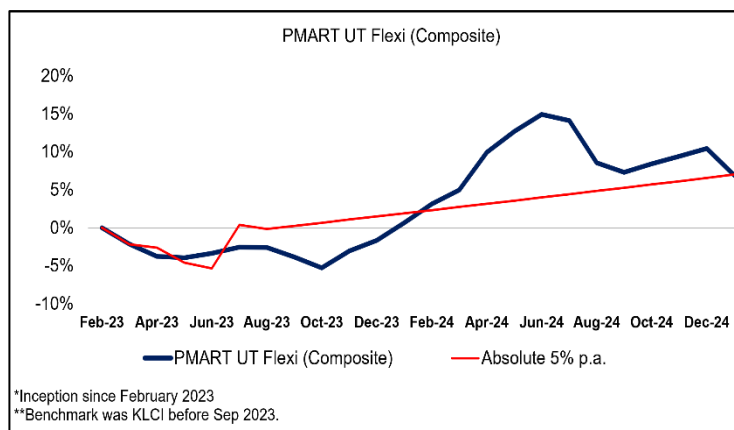

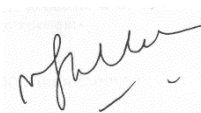
